National First VP Laura Gutteridge arranged for the following write up on this Chapter and NARBW in the July 31, 2014 publication of "Inform & Involve" for Professional Railroaders by the CSX Safety & Career Development Team:

"The National Association of Railway Business Women ("NARBW") had its beginning during the Roaring 20s when the first chapter was organized in the Twin Cities-Minneapolis and St. Paul. Seven Twin Cities women, all employed in various offices of competitive railroads, but known to each other only as telephone voices, met for dinner in January 1921.

"The purpose of NARBW is to stimulate loyalty and interest and foster cooperation and a better understanding within the railroad industry and its affiliates; create good public relations for the railroad industry; and undertake charitable, benevolent and social welfare projects.

"In 1978, the organization began a scholarship program. The scholarship program continues to

grow annually and scholarships are awarded at the National Convention. Members of NARBW and their relatives are eligible to apply. All applications are judged on scholastic ability, ambition and potential. Since its inception, the scholarship program has awarded nearly \$300,000 in scholarships.

At the national level, CSXT is currently represented by Laura Gutteridge serving as National 1st Vice President and former National Presidents include Doris Stemmer, Ruth Ann Spears, Sandy Hall, and Barbara Barthle, all originally from the Jacksonville Chapter, with Doris now a member of Cincinnati and Ruth Ann a member of the Louisville Chapter.

"Any woman who is currently or formerly employed, or is a relative of someone in a railroad or railroad-connected industry may join. Membership must be approved by the chapter board of directors.

As a Member-at-Large you receive *The Capsule*, which is the national newsletter, may attend chapter meetings when you are in an area where a chapter exists, as well as the national convention.
