

Final Report of National Residence Chairman - Stella Miller

Immediately after the purchase of our residence at Boca Raton (authorization having been voted at the Dallas Covention in 1958 for purchase of same) I was appointed Residence Chairman and have been acting in that capacity for the past two years.

I immediately made a trip to Boca Raton to look over the property and since that time I have made many, many trips down there. Between the time of my appointment and the first Board Meeting held in Chicago in November of 1958, I made a survey of the retired members, sending out approximately 600 letters. I received many replies but no one said they were interested in living at the residence at that time. All of this was reported in my first report published in our National Magazine. I reported to the National Board the results of my survey and it was then decided that we retain the services of Day Realty Company at Boca Raton for the purpose of renting the apartments to outsiders in order to try to make expenses on the property in the interim. This was done.

At the Convention in Philadelphia, in 1959, it was again decided by the covention body to continue the operation of the residence as it had been operated the previous year.

At the 1959 Spring National Board Meeting held in Chicago I was authorized to spend \$1000 for painting of the residence. When I went down to make the final ar-

rangements for the painting in February, which I had purposely delayed because of the weather and too, trying to avoid disturbing the tenants as much as possible, with open windows, etc. during the process of painting, the contractor told me he had found some of the windows so warped they would not close. He was authorized to go ahead and repair them before starting on the painting, which repairs were made.

The exterior of the apartment has now been painted white and flamingo which makes the building look much larger than when it was painted a chocolate brown. The contractor suggested a new hat to go with the new dress, i. e., an aluminum paint job on the roof, but it looks very well without the additional expense, and too, I was advised the roof was in good shape as it is.

At one of the National Board Meetings it was recommended that we tear down the garage to save the cost of painting same. I was advised against tearing it down as it was thought by the Day Realty Company and the contractor to add a lot to the value of the property, so this idea was dismissed.

We have had to replace many of the electrical appliances in the apartments and I am advised that the water heater for Apartment 1, will soon have to be replaced.

The water sprinkler system in the yard has completely rusted out and to replace the same it will cost approximately \$200.00. This is, of course, a very necessary thing in Florida as lawns must be watered if they are to grow. This has not been brought before the Board as yet.

I was advised by the Day Realty Company that the wiring of the residence is completely inadequate for the load it has to carry; that they were advised when the house was wired, the wire used was much to small for the building and with the many appliances used therein, the load is too much. It has been recommended that we have the entire building rewired, because there is a bad fire hazard existing at the present time. I am getting an estimate on what this will cost.

All of the apartments are now rented, even the small room and bath in the basement.

We were fortunate in getting a very good yard man and he has gotten the yard and the shrubs in splendid condition. The Miami Chapter asked permission to replace some of the worn out shrubs and the National Board, in March 1960, granted this permission, with the approval of the National Residence Chairman and the yard man.

It was necessary that we purchase 100 pounds of fertilizer for the yard and additional fertilizer for the shrubs and trees, in February of this year.

As I have reported, we had to practically refurnish Apartment 5 before it could be rented last fall. It was completely repainted on the inside, a new refrigerator was placed in the apartment, some of the furniture replaced, some repaired, and the drapes and throw rugs were all cleaned. The apartment looks very nice now. I am glad it had just been done when some of our northern members visited the apartment as it was certainly an improvement over what was there before.

Articles have appeared in various magazines — (not pointing their finger directly at the Residence Chairman — but WHO ELSE) which have inferred that in contacting the retired members we have not done enough. They seem to think we should contract the prospective retired members. We have already done this through our National Magazine, if, of course, the magazines have gotten to the entire membership, through their local chapters. We have no way of knowing who is about to retire or contemplating retirement within say the next 2, 3, or 5 years, but if those

members have read the National Magazine, they are fully and accurately informed. If they desired more information, they were free to ask for it through their Residence Chairman. I have tried to answer every inquiry I have received from members, if I have missed one I am truly sorry, for I have tried in each instance to give those who have made inquiry the true facts to which they were entitled.

One of our great problems now and one that should be straightened out but - HOW? I don't know. Our tenants complain bitterly about being annoyed by our members visiting the residence and insisting on seeing the apartments. Surely they must know that rented property is not available for personally conducted tours by the owners. And too, they must be mature enough to know that since the aquisition of the property it has not been operated as a residence for retired women, not through any fault of ours, but because we have not been able to find retired women who are ready to go to a home. If we can just keep our members from annoying our tenants until the residence is operated as a residence for our members, we will have accomplished at least something.

Another problem which is almost as had - that is the various publications quoting this and that about the residence. Now don't misunderstand me, I am not blaming the individuals, they are probably, from the reports, quoting something they have read or been informed by some individual who wasn't in the "KNOW". I am sorry for them, but I do think it would be nice if they would think twice before informing people of something they apparently know nothing about. What is it that Abe Lincoln said - or maybe he didn't, but someone said it - HE WHO TALKS WITHOUT THINKING RUNS MORE RISK THAN HE WHO THINKS WITHOUT TALKING.

In this issue there is a complete financial statement on the Residence, prepared by our Treasurer, Janice Marks.

As most of you know, if you have read my various reports during my term of office, Apartment 1, set aside for our members was redecorated and refurnished. Those who contributed to this are the following: Mobile Chapter, Miami Chapter, Elizabeth Greene of the Atlanta Chapter, Bess Bowling and Gladys Class of the Columbus Chapter, Delia Aldrich of the St. Louis Chapter, and I, of the Jacksonville Chapter. All of this

has been greatly appreciated and added much to the comfort of our members who have rented the apartment in the last two years.

It has been suggested when Apartment 4 is empty that we change and set aside Apartment 4 for the members in lieu of Apartment 1. Apartment 4 is larger and I think our members would enjoy it more. (This apartment now rents for \$100.00 per month.) Perhaps the rent would have to be adjusted but time will take care of that. Evelyn Pierce, one of our Past Presidents, selected Apartment 1 to be set aside for our members, but I do think Apartment 4 might be more desirable, however, we would be losing \$100.00 a month rent; and have not rented the NARBW apartment too many months out of the year.

I have had many nice letters from our members occupying Apartment 1 and all have enjoyed their stay at the residence very much. I think at time goes on the members will become more and more interested in thinking of our residence as a home. I also think in the beginning it was hard for them to realize that their dream had actually become a reality.

Many, many hours of hard work have gone into being your Residence Chairman these past two years and I have enjoyed it, and have tried to the best of my ability to do just as I was directed to do, although there as some who disagreed completely. Perhaps when they know more about the actual situation they will be more tolerant of a Residence Chairman.

Many suggestions have been submitted to me on how to operate the residence. Some of them were good, but not practical, and others have criticized its operation severely. This is, of course, their privilege. I was only sorry that those who criticized did not contact me and let me advise them of the many, many things that entered into the picture, of which they had no knowledge, and evidently were not interested in. All is not gold that glitters. They only saw what appeared on the surface, having no conception of the many, many difficult problems with which we were being confronted each day.

I want to express my deep appreciation to our President for having given me the privilege of serving as Residence Chairman. It has really been an education as well as a revelation in many different ways. I assure you I am much the wiser for having had the experience.

Please be more tolerant of your next Residence Chairman. It is a job, I assure you.

In closing I would like to quote from an unsolicited letter from one of our members from St. Paul that spent considerable time down at the Residence this year.

"I am awfully sorry that I missed you both times — but I hope I can stay at the residence again some time and perhaps meet you or maybe at a convention.

"Several of the girls have asked me about the residence and I have very frankly told them that the apartment we use is fine, everything to keep house with in it. That Boca Raton is a wonderful place, lots of fresh air which I appreciated so much as our air is so polluted with industry smoke and I also appreciated that wonderfully soft, soft water. Here - we have water as hard as stone. But I have also told them frankly that the residence itself it not in a good location for elderly retired women as there is absolutely no transportation. Some have said, 'it is 5 minutes from the station, or 10 minutes from the stores' etc, but that means nothing if you have no car, One certainly cannot walk to the station or to the stores."

As to taking over Apartment 4 eventually — for the use of the girls — perhaps it would be a good idea. I have had some of the girls ask me if the small apartment would hold more than two people. BUT it would depend, I should say, on how many requests or inquiries you have received from groups of 3 or 4 or more. And would the girls want it every month of the year. The way it is now you are getting regular rent every month and it would be too bad to lose that just to rent it to the girls for two or three months in the winter time.

Again thank you for the privilege of serving you for the past two years as your Residence Chairman. I have served you to the best of my ability.

Day Realty Company charges 5% of amounts collected for their services which consists of daily visits, overseeing tax problems, licenses, collection of rents, and all other problems confronting us. (5% of amount collected figured against having someone living on the property in apartment rent free which rents for \$60.00 per month — \$720.00 per year.)
