

# LEARNING CENTER

### CREATING AN EFFECTIVE RESUME, PART III

Welcome to our final installment of Creating an Effective Resume! This quarter, we will talk about recommendations and other considerations in creating an effective resume.

First, write your own resume. You need to know your resume inside and out and the best way to do that is to write yourself. Make sure to study your resume before any interview. You want to make sure that your resume is tailored to the job description. The best way to show a hiring manager that you are the best person for the job is to have your resume match up as closely as possible to the characteristics and experience that were requested in the job description. You also want to make sure that you write your resume to show the responsibilities you have handled and results you have achieved. It is critical that you keep your resume brief, clean, and easy to read. Remember that there could be many applicants and you want to make reviewing your resume as easy as possible for the hiring manager.

Many job seekers tend to be vague in their descriptions. You want to be very specific about your job accomplishments and achievements. What makes you stand out from the crowd? What would your co-workers say your specialties are? These are the items you want to make sure are outlined in your resume. Avoid subjective language and illustrate your experience using statistics or numbers to show your results.


Always send a cover letter with your resume. This is your chance to express your enthusiasm about the position and gives a personal touch to your application.

Optics matter. Use professional resume paper and bring printed copies of your resume to the interview for each person on the hiring committee. Format wise, use 1 - 1.5" margins and 12 font size of standard type face in black ink. Resumes can be one or two pages though you may find in some industries that even more pages are necessary. If you have more than one page, make sure to use page numbers and include your name at the top of the page.

Do not staple or paper clip your resume – your name and page numbers are sufficient to tie multiple pages of a resume together.

Do not rely solely on spell check. Read your resume out loud. Have a friend or two read your resume. You would be amazed at the things you can find when you do this. You should also ensure you use proper punctuation and grammar. I can tell you as a hiring manager myself that if I see a misspelling, that is a huge red flag – if you cannot spend the time making your resume crisp in order to get a job, why should I trust you to take care of the details at a job working for me?

Here is a list of some resume topic no-nos. Make sure to not include any information on these topics in your resume. You want your resume as neutral as possible in this regard to ensure equal consideration of job candidates.

Marital Status

Children

Spouse Employment

Age

Race

Photo of yourself

Religion

Politics

Height/Weight

Health

Salary

Traditionally, language regarding references was included in the resume. Not today. It is a given that you have references available upon request, so there is no need to state as much on your resume. Save that critical space for your experience and skills. Since it is a given, make sure you have your references lined up, so that you can provide them at any time. Always ask permission to use a person as a reference. Make sure that you supply each reference with a copy of your resume and you have current contact information for each reference.
