The 61st Annual National Convention held in Louisville, KY, May 10-14, 2005 was represented by 22 of our 25 chapters, 126 members with a voting strength of 90 delegates.

LEGISLATIVE REPORT

WASHINGTON UPDATE



NIT LEAGUE NEUTRAL ON RE-REGULATION BILL

The National Industrial Transportation League, the largest shipper organization, agreed to remain neutral on the recently introduce re-regulation bills (S.919 and H.R.2047). The identical House and Senate bills seek to re-regulate the railroad industry through means such as reciprocal switching, mandated rate quotes, and the elimination of paper barriers. Industry experts believe that should the bill pass, it could cost the railroad industry \$4 billion. This comes at a time when railroads are trying to set aside additional resources for capacity enhancements and other capital investments. The industry is currently visiting all members of the House and Senate committees of jurisdiction to urge their opposition to the bill. The Senate bill, introduced by Senator Conrad Burns, (R-MT), currently has nine co-sponsors. The House bill, introduced by Richard Baker, (R-LA), has 19

TEA-21 Extended for Eighth Time

The transportation reauthorization bill known as TEA-21 was extended to July 19th. Conferees to the joint House-Senate Conference committee on the bill hope that over the July 4th Recess as well as the two weeks following, they will reach agreement on the remaining differences. Conferees reached a tentative agreement on the overall funding number of \$286 billion as well as the funding level for public transit. The conferees still need resolution of the House and Senate share of individual member projects as well as each state's guaranteed allocation. The original bill expired in September 2003.

AMTRAK Receives \$1.176 Billion in House

Last week, Congressman Steve laTourette (R-OH) and Congressman Jim Oberstar (D-MN) successfully increased Amtrak's proposed House FY 2006 funding to \$1.176 billion. Their amendment, to add \$657 million to Amtrak's Appropriations Committee-approved level of \$550 million, passed the full House by voice vote. Congresswoman Corrine Brown (D-FL) also succeeded persuading her fellow House colleagues to vote for her amendment which sought to restore funding to 15 long-distance and three short-distance Amtrak routes. Her amendment passed 269-152.

The Senate Appropriations Committee will begin its debate on Amtrak funding the week of July 11th after Congress returns from recess.


